How We Use Your Personal Data

DG Accountancy Services Limited takes your privacy very seriously and will never disclose, share or sell your data without your consent; unless required to do so by law. We only retain your data for as long as is necessary and for the purpose(s) specified in this notice. Where you have consented to us providing you with promotional offers and marketing, you are free to withdraw this consent at any time. The purposes and reasons for processing your personal data are detailed below: -

- We collect and store your personal data as part of our legal obligation for business accounting and tax purposes
- We have a legal obligation to share your personal data with CreditSafe who are a credit reference agency and provide us with financial background checks prior to you commencing an engagement with us
- We will occasionally send you marketing information where we have assessed that it is beneficial to you as a client and in our interests. Such information will be nonintrusive and is processed on the grounds of legitimate interests

Your Rights

Where applicable, you have the right to data portability of your information and the right to be informed about any automated decision-making we may use.

If we receive a request from you to exercise any of the above rights, we may ask you to verify your identity before acting on the request; this is to ensure that your data is protected and kept secure.

Safeguarding Measures

Transfers Outside the EU
